4a (Code:) (Expenses \$ 288,248. including grants of \$ 391.) (Revenue \$ 62,670.) The Art Association of Jackson Hole taught 84 classes, workshops and symposia to more than 435 adult students. Workshops include coursework with 4 esteemed visiting artists. Class offerings included drawing, painting, ceramics, printmaking, and digital photography in 5 state of the art studios through group & private lessons.

4b (Code:) (Expenses \$ 235,010. including grants of \$ 14,695.) (Revenue \$ 136,546.) The Art Association of Jackson Hole served youth through 67 art classes and workshops for 623 children, from ages 2 through 18 years. The Art Association of Jackson Hole offers robust after school and summer camp programs, an asset to working families in the region. The Outreach program partners with more than 30 local human services organizations to bring art experiences to underserved populations including 187 children, elderly, and the disabled and 485 hours of instruction.

4c (Code:) (Expenses \$ 183,434. including grants of \$) (Revenue \$ 77,920.) The Art Association of Jackson Hole held five exhibitions showcasing 150 local, regional and nationally recognized artists. The gallery also served as a venue for annual Teton Mudpots sales giving ceramics artists an opportunity to sell wares. The annual art fairs were cancelled this year due to COVID. We were able to offer a Pop-Up art fair which gave 23 artists the opportunity to exhibit and sell their artwork.
